Oratorical: The Department of Colorado had a very successful Oratorical contest this year. This was the first year in our new venue, Golden View Classical Academy. We have already secured this location for next year's event. We had 13 students compete this year. The Results are as follows: 1st place Emily Kastens Post 1187, 2nd place Rachael Densmore, Post 1, 3<sup>rd</sup> place Jackson Kastens Post 1187, 4th place Mae Webster Post 1260. All these students were excellent contestants! This was the closest competition we have ever had. Judges had a tough time this year. The judges got it right! The Department of Colorado is sending a true Champion to the finals in Indianapolis April 22-24, 2022. Our 2023 contest is already set for Saturday February 4, at Golden View Classical Academy.

Children & Youth Pete Sierminski: As of April 1, Colorado has donated \$2,100.00 to CWF.

**Public Relations:** Mark Kilstrom is again printing his *Electronic Update*.

<u>Legislative Richard Humphrey:</u> House bills to protect the flag, veterans deportation protection plan, and Senate buddy check bill are still languishing in Congress. Richard felt that the Washington Conference was great.

VA & R Nick Arceo: I attend the VA&R monthly Zoom calls. Here are the three goals for this year; 1) promote Veterans National Assistance Day, May 21st (3rd Saturday in May), 2) increase Charles Rigsby Volunteer of the year award to 20 applicants, 3)Increase VA Reps & Deps by 10% nationally (down to 28 from a high of 51...we need 3 to move the needle 10%) Here are the notes of the last meeting; please promote Veterans National Assistance Day, there is a poster coming out on this soon, it has been sent to Ken George for approval. Look for candidates for the Rigsby Award. RE the Reps & Deps, we continue to have a decrease in this area. We don't want to lose our seat at the table. We are really having problems with The Legion side...The Legion that they have to certify Reps & Deps, and at times feel only Legion members should be in these positions, Committee member Gabe Cinquegrana has had no response from The Legion regarding our concerns in this matter. Why can't we (SAL) confirm our own people?

VFHV, Volunteers for Hospitalized Veterans update. Our group takes care of the 30 beds of Veterans on the 2<sup>nd</sup> floor, which is a psychiatric lock down unit. We supply these Veterans all necessary items including clothes, personal need items, etc. We have not been allowed to set up our selling at the VA Hospital. We have taken our items to an outside business in Castle Rock, Mountain City Supply. Lots of Veterans visit this business and our sales are increasing slowly. Thank you to The Detachment of Colorado for giving us funds to assist our efforts for these Needy Veterans.
